Executive Summary

This is provided to Council for information to understand the number of permits issued throughout Grey County and within each local municipality. These harvests are selective harvests that are classified as good forestry. Permits are sent to the respective municipality when they are received, so that if there are corresponding processes then the municipality will have enough time to obtain that information.

Background and Discussion

This is provided to Council for information to understand the number of permits issued throughout Grey County and within each local municipality. All of these harvests are selective harvests that are classified as good forestry.

Permits are sent to the respective municipality when they are received, so that if there are corresponding processes (i.e. road permits, half load restrictions, etc.) then the municipality will have sufficient time to obtain that information.

January 2019

County Forest Operations

Dornoch Tract (20) was completed in early January. The harvest operation looks good; completion was delayed due to weather and machinery break downs.

Sullivan Klondyke (43) was completed in early January. The harvest looks good, trails were smoothed out before the ground was frozen and should be good in the spring.

Copper Kettle (31) hardwoods were completed in early February. Snowmobile trail is open again. Good job, a large pile of cut offs is on the landing and will be cleaned up in the spring.

No harvesting occurred in County forests in March.

Tree marking for 2020 harvests has been completed by Lands and Forests Consulting. The tree marking has been reviewed and approved by Grey Sauble Conservation Authority staff.

Legal and Legislated Requirements

Forest permits (Intents to Cut) are administered by the By-law Enforcement Officer as per the Forest Management By-law.
