11.0 Other

11.1 Public Health Modernization

Dr. Arra updated the board on the Public Health Modernization process. On May 27, the government reversed the retroactive budget cut for 2019; Dr. Arra discussed plans to utilize these funds. The CMOHs attending the alPHa conference shared a timeline for consultation; discussion with alPHa and AMO will take place in June, Board consultation in July, and Provincial Government consultation in

August. Dr. Arra has met with two local MPPs, Lisa Thompson and Bill Walker. Meetings were positive and both support of our vision. Dr. Arra presented our vision to Grey County Council, and also plans to deliver similar presentation to the Bruce County Council.

11.2 alPHa Conference Update

Dr. Arra provided an update on the alPHa conference, June 9 - 11, reporting the resolutions that were passed. Two resolutions were of note, one on adapting to the impacts of climate change, and the other on public health support for accessible, affordable, quality licensed child care.

11.3 Board Membership Term

Dr. Arra explained that generally the Board is elected on an annual basis, but with impending amalgamations he suggests either extend the Board term until April 1, 2020, or for a two-year term. The Board opted for a two-year term. As they are responsible for Board appointments, enabling revisions will be required from the two counties.

WHEREAS, the Board of Health Members are appointed on an annual basis by the respective Grey County Council and Bruce County Council; and

WHEREAS the Board of Health recognizes that the new Regional Health Entities would exist as of April 1, 2020 and having a new Board elected as of December 20, 2019 would negatively affect the amalgamation process;

NOW THEREFORE IT BE RESOLVED THAT the Board of Health for the Grey Bruce Health Unit requests that both Grey County and Bruce County prepare enabling revisions, as required, to amend the current Board term from one-year to two-year terms.

AND FURTHER THAT the new term apply to the current Board of Health which would extend their term until the earlier of December 2020, or when the new regional Board is created.

In light of the modernization process and due the fact that changing remuneration of the elected Board members requires policy changes in both counties, which would take months to be completed, Dr. Arra suggests that this item be deferred until the end of this Board's term with the Grey Bruce Health Unit.
