

Minutes

Committee of the Whole March 23, 2023

Grey County Council met on the above date at the County Administration Building. Warden Milne assumed the Chair and called the meeting to order at 10:27 AM with all members present. Councillors McKay and Bordignon participated electronically.

Declaration of Interest

There were no declarations of interest.

Business Arising from the Minutes

There was no business arising from the minutes.

Delegations

Al Leach, Vice President - Saugeen Valley Children's Safety Village - 2023 Presentation & Update to Grey County Council

Al Leach thanked Grey County Council for their support and presented an update on the activities and initiatives of Saugeen Valley Children's Safety Village, including safety training programs, village visits, and Super Safety Day events.

Al Leach noted a Community Engagement Workshop on March 31, 2023, and ongoing fundraising initiatives, such as charity golf tournaments. Al Leach described how the Saugeen Valley Children's Safety Village provides hands-on training and programs, including fire, farm, and water safety, and the Super Safety Days events that introduce children to emergency response providers in a controlled and positive environment. The Children's Safety Village provides hands-on, interactive safety training to 4,000 children annually part-time and described the organization's goal to operate full-time to support 10,000 children annually. Further, Al Leach highlighted initiatives for the coming year, including school tours, Super Safety Days events, safety programs geared to seniors or local Mennonite Community schools, and the anticipated return of Halloween events.

In response to questions from the Committee, representatives noted future newsletters to learn of upcoming events or programs and discussed government support for children's health and safety initiatives. Grey County Council thanked Al Leach and the volunteers supporting the work of the Saugeen Valley Children's Safety Village.

Long-Term Care Redevelopment Planning Task Force – March 21, 2023 – Motion RP05-23 to Refer Consideration of Report FR-RP-07-23 - Financial Impact Assessment Rockwood Terrace Project to County Council

CAO Kim Wingrove presented to the Committee regarding the funding for the redevelopment of Rockwood Terrace. The CAO provided the background for long-term care in Grey County, current funding sources and demands for long-term care, the differences between long-term care, retirement, and assisted living facilities.

Kim Wingrove reviewed recent Rockwood Terrace project activities and redevelopment costs and funding. The CAO described that following a November 2022 announcement of additional funding, a significant increase in projects entered the development pipeline. In February 2023, it was noted that the ministry provided accelerated timelines and required milestones to qualify for this funding.

Mary Lou Spicer described the components of redevelopment funding, including the process and considerations for debenture to support the project. The Director reviewed Grey County's Debt Management Policy, the provincial annual repayment limit, and the potential impacts on future capital projects.

In response to questions from the Committee, Mary Lou Spicer discussed possible supporting revenue and previous estimates for interest rates.
