Status: Recommendation adopted by Committee as presented per Resolution TAPS35-16; Endorsed by County Council CC37-16 March 1, 2016;

Recommendation(s)

WHEREAS the 2016 budget included \$364,444 for pulverizing and paving, guiderail replacements, design, tendering, construction inspection and quality assurance on Grey Road 3;

AND WHEREAS \$27,500 was included in the tender for additional work to be funded from the minor capital budget;

NOW THEREFORE BE IT RESOLVED THAT Report TR-TAPS-19-16 being a report containing the tender results for RFT-TS-08-16 be received;

AND THAT RFT-TS-08-16 be awarded to Harold Sutherland Construction Ltd. for a bid price of \$327,651.93, excluding HST;

AND THAT with 5% contingency, 5% engineering and quality assurance allowances added to the tender price, the revised estimated project cost is \$366,760.46 net HST.

Background

The tender for the pulverize and hot mix paving of Grey Road 3 was posted on the County of Grey's website from Tuesday, January 19, 2016 until Tuesday, February 2, 2016.

The work includes pulverizing, applying granular, paving and replacing guiderail on a 1.7 kilometre section of Grey Road 3, from the Bentinck-Sullivan Townline to the north junction of Grey Road 25. Some additional paving at the intersection of Grey Road 25 and the Grey-Bruce Line (Scone) is also included in the tender (minor capital project) in order to utilize economies of scale. The tender includes paving two lanes a width of 3.25 metres and paving 1.25 metre shoulders.
