PDR-PCD-13-12 Official Plan Amendment Merit Report Re-Designation from "Agricultural" and "Hazard Lands" to "Mineral Resource Extraction" and Hazard Lands", Township of Southgate,

Part of Lot 1, Concession 16 (Geographic Township of Egremont) Applicant: H. Bye Construction, County File No.: 42-07-06-OPA-115

Sarah Morrison presented the above-noted report regarding an application to amend the County Official Plan to allow for the expansion of an existing pit operation. Staff recommended that the proposal proceed to a public meeting. Questions and comments ensued.

CCR-PCD-27-12 Economic Development Implementation Plan

Bryan Plumstead presented the above-noted report which briefly summarized the study process utilized by Matthew Fisher & Associates, presented the recommendations in the consultant's report and suggested an implementation plan. Following deliberation between model A and model B by the steering committee, the consultant conducted a secondary analysis of the quantitative and qualitative components and subsequently supported model B. The importance of the differentiation between community development and economic development was recognized.

An amendment to the below resolution was proposed by Councillor Eccles to remove the reference to Bruce County. No seconder was obtained at the time.

NOW THEREFORE BE IT RESOLVED THAT the request from the Bluewater District School Board to host the Bluewater Athletic Association (BAA) Mountain Bike Race May 1, 2012 in the Derby Tract be approved subject to the completion of the appropriate land use agreement;

AND THAT approval be given to host the event prior to May 1, 2012 County Council in order to accommodate the event date of May 1, 2012.

# Correspondence

Letter and Newsletter from the Bluewater Wood Alliance dated January 27, 2012

The Bluewater Wood Alliance requested a second year of funding in the amount of \$2,381.33 and offered to present an update as a delegation to the committee. A newsletter updating the year's accomplishments was also included. Mr. Plumstead noted that these funds were already included in the budget for 2012. It was noted that this is a highly effective economic development endeavour and that a delegation of the alliance would be an appropriate opportunity to celebrate. Staff were directed to invite the Bluewater Wood Alliance to present as a delegation at an upcoming session of County Council.

Globe & Mail Article Wood Firms Cluster for Survival and Growth dated March 31, 2012

The focus of the article is the collaboration between business owners to maximize economic development and stability.

Letter from the Ministry of Tourism, Culture and Sport regarding the future funding model for tourism dated April 3, 2012

The letter acknowledged that each of the tourism regions are very different and supported the industry's initiative to voluntarily collect marketing fees where desired. Tourism Minister Michael Chan also confirmed the government's commitment to providing \$40 million in annual funding to the regional tourism organizations as well as its support of the regional approach.

Township of Havelock-Belmont-Methuen resolution regarding Ontario wildlife damage compensation program

The Township of Havelock-Belmont-Methuen requested the support of Ontario municipalities as well as the Minister of Agriculture, Food and Rural Affairs and the Association of Municipalities of Ontario in their resolution requesting that the eligibility requirement of a valid farm business registration number be removed from the application for wildlife damage compensation.

#### **Other Business**

Mr. Taylor provided an update on Official Plan Amendment (OPA) 80, the five-year official plan review for Grey County. Signed minutes of settlement have been received by two appellants, Cuesta Planning Consultants Inc. and Insicon Inc. These minutes of settlement will need to be approved by the Ontario Municipal Board (OMB), and staff are still waiting on a pre-hearing date to be scheduled.

A meeting was held including the County of Grey, Town of Hanover and Municipality of West Grey wherein some ideas for the resolution of the Hanover appeal were identified. Wording is being drafted and will be presented to the parties relating to this.

Committee inquired about which official plan policies are in force and effect: the existing policies or the OPA 80 policies. Mr. Taylor noted that section 17 (38) of the Planning Act indicates that those sections not under appeal are in force and effect. Mr. Taylor further noted that when OPA 80 was first appealed, staff worked with the appellants to try to scope the appeals, to determine what was under appeal, but were unsuccessful in this regard. Based on the appeals submitted, it is somewhat unclear as to exactly what is under appeal and, therefore, it is unclear what remaining policies could be considered in force and effect.

A future OMB pre-hearing should assist in clarifying the matters in this regard. The matter is further complicated by the Board's ability to retroactively approve those policies not considered to be under appeal back to the day after the last date of the original appeal deadline. Staff are continuing to work to resolve this matter.
