#### Call to Order

#### **Presentation**

Doug Snyder and Sheva Zohouri, Snyder and Associates – Redevelopment Review of Rockwood Terrace

Snyder and Associates were contracted by Grey County to complete a detailed evaluation of the existing Rockwood Terrace facility. Mr. Snyder reviewed a summary of the findings and provided information regarding the preferred option for redevelopment. Extensive discussion followed. It was noted that the redevelopment report and the recommendations it contained will be used as part of the discussion to determine Grey County's commitment to long-term care.

Mr. Snyder and Ms Zohouri were thanked for their presentation and left the meeting.

#### **Reports - Long-Term Care**

LTCR-SS-06-12 - Rockwood Terrace Redevelopment Review

Part of the County's strategic plan is to confirm the County's desired level of investment and involvement in the provision of long-term care services.

With the information provided in the redevelopment review completed by Snyder and Associates, it was recommended that a task force be formed and directed to prepare a report for Council's consideration of Grey County's future commitment to the provision of long-term care.

It was also noted that when infrastructure funding opportunities are provided through the Ministry of Health and Long-Term Care, typically the timelines for applications are short. In order to take advantage of any funding opportunity, County Council would need to have an established commitment to proceed with redevelopment.

WHEREAS it is a stated Strategic Objective of Grey County Council to undertake a review of its ongoing investment and involvement in the provision of long-term care services in the county;

AND WHEREAS it was determined in 2011 that an assessment of the capital improvements required at Rockwood Terrace needed to be completed before undertaking the larger service review in 2012;

AND WHEREAS an independent assessment of development/redevelopment options for Rockwood Terrace has now been completed;

NOW THEREFORE BE IT RESOLVED THAT report LTCR-SS-06-12 and the development/redevelopment assessment by Snyder and Associates Inc. be received;

AND THAT the findings and recommendations contained in the Snyder and Associates Inc. report be used to assist in a review of the County's desired level of ongoing investment in long-term care services;

AND THAT staff and a task force consisting of the Warden, Chair of the Social Services Committee and Councillors Deborah Haswell and John Bell, be directed to prepare a brief report on the advantages and disadvantages of service delivery options available to the County in fulfilling its obligation to provide long-term care services.
