Status: Recommendation adopted by Committee as presented per Resolution TAPS67-15; Endorsed by County Council May 5, 2015 per Resolution CC67-15;

Recommendation(s)

WHEREAS the 2015 budget for the Grey Road 40 project was \$509,715, the proposed work consists of pulverizing and paving, culvert replacement, design, tendering, construction inspection, and quality assurance;

AND WHEREAS RFT-TS-12-15 for Grey Road 40 Pulverize and Hot Mix Paving was issued on Wednesday March 18, 2015 and closed on Wednesday, April 8, 2015;

NOW THEREFORE BE IT RESOLVED THAT Report TR-TAPS-34-15 being a report containing the tender results for RFT-TS-12-15 be received;

AND THAT RFT-TS-12-15 be awarded to E.C. King Contracting for a bid price of \$474,030.15, excluding HST;

AND THAT with a 10% contingency and 5% engineering and quality assurance allowances added to the tender price, the revised estimated budget for this project is \$554,729.04;

AND THAT the shortfall of \$45,014.04 be funded as per TR-TAPS-45-15 Construction, Resurfacing and Minor Capital Budget update report.

Background

The tender for the pulverize and hot mix paving of Grey Road 40 was posted on the County of Grey's website from Wednesday March 18, 2015 until Wednesday April 8, 2015.

The proposed work includes pulverizing and paving the existing surface to minimize maintenance costs and improve the safety of the road.

Culvert replacements are also included in the contract.

The original project cost was estimated using 2014 construction prices. With the significant drop in oil prices it was felt that this was a very conservative estimate; however, the unit price for hot mix has increased resulting in this tender being over the estimated budget.

The bid summary is listed below:

RFT-TS-12-15 Grey Road 40 Pulverize and Hot Mix Paving (4.2 km).

It is recommended to award RFT-TS-12-15 to E.C. King Contracting in the amount of \$474,030.15 excluding HST.

Financial / Staffing / Legal / Information Technology Considerations

The chart below identifies the total tender approved costs. Funding sources include the gas tax. It is recommended that the shortfall be obtained from the surplus in the construction, resurfacing and minor capital budget.

As projects are tendered this year, the individual budgets will be adjusted to ensure the overall budget is not exceeded.
