Recommendation

1. That Report TR-CW-13-20 containing the tender results for RFT-TS-01-20 Grey Roads 11 and 15 Rehabilitation be received; and
2. That E.C. King Contracting be awarded the Tender for a total amount of \$1,537,910.25 excluding HST.

Executive Summary

This project consists of two schedules:

Schedule A: Grey Road 15 from 200 metres east of Queen Street / Tom Thompson Lane in Leith to 600 metres south of Annan, for a total length of 2.3 kilometres of road rehabilitation and reconstruction. This project includes the following:

- 3.50 metre lanes with 1.25 metre paved shoulders;
- Guiderail upgrades and replacements;
- Pulverize and pave rehabilitation;
- Urban reconstruction with storm sewer and curb and gutter replacement in Annan;
- The roadway will be open to traffic with intermittent alternating lane closures;
- The anticipated project window falls between July 20, 2020 and September 18, 2020.

Schedule B: Grey Road 11 from 200 metres south of Highway 26, northerly to Highway 26 for a total length of 0.2 kilometres of road rehabilitation. This project includes the following:

- 3.50 metre lanes with 1.25 metre paved shoulders;
- Pulverize and pave rehabilitation;
- The roadway will be open to traffic with intermittent alternating lane closures;
- The anticipated project window falls between July 20, 2020 and September 18, 2020.

The project was tendered as a complete award for the combined total of the two schedules.

It is recommended to award RFT-TS-01-20 to E.C. King Contracting for the bid amount of \$1,537,910.25 excluding taxes.

Background and Discussion

The Tender was posted on the Grey County website from May 13, 2020 until June 3, 2020. The bids received are shown below:

The ten percent contingency is being applied to cover off fluctuations in the Asphalt Cement Index and any unforeseen issues that may need to be addressed on this project.

Staff recommends that the shortfall for this project be funded from any surplus realized from within the 2020 Capital construction budget, or if a surplus is not available, from the Federal Gas Tax Reserve.

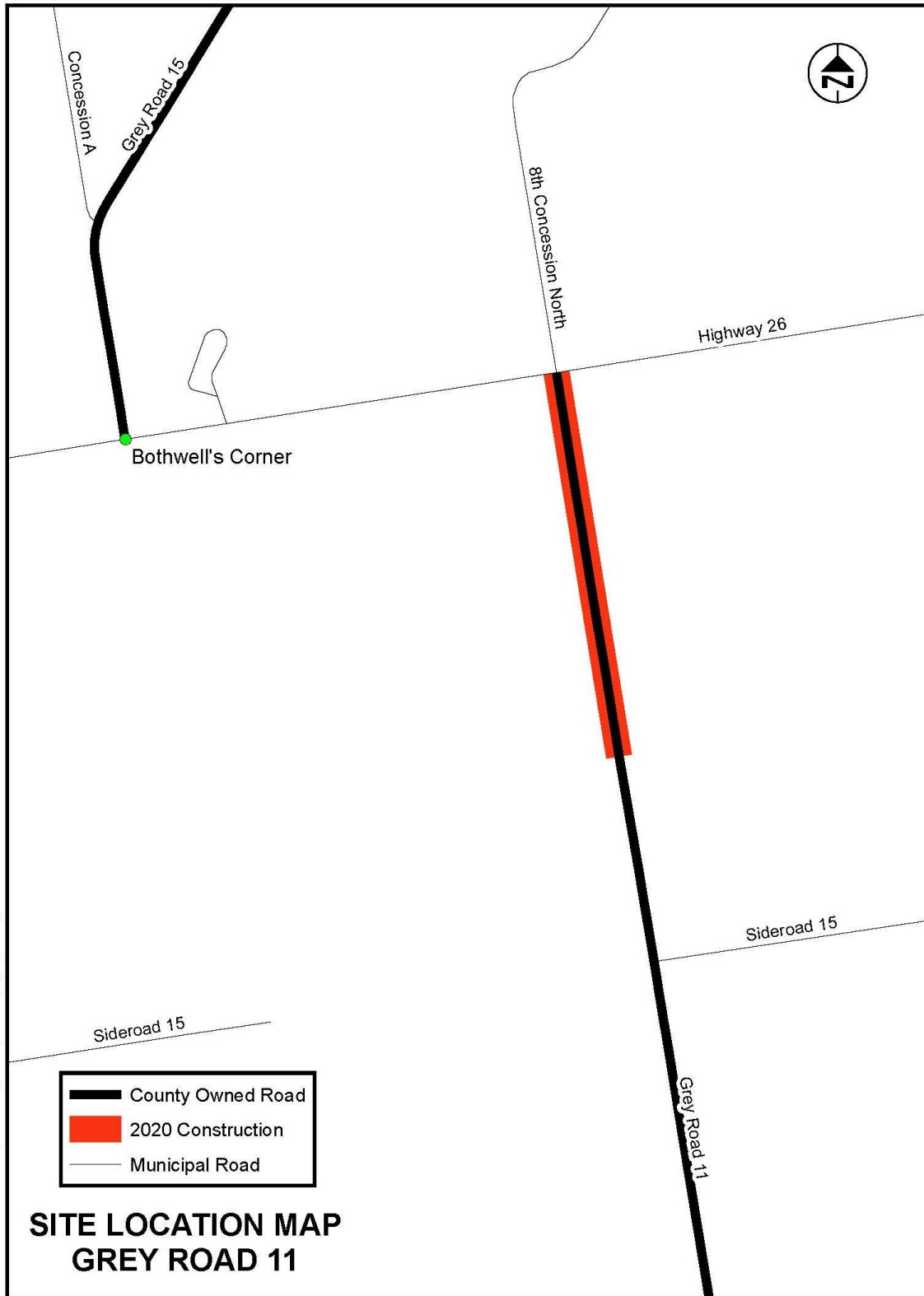
