### Call to Order

The Chair called the meeting to order at 1:30 PM. The Committee members and guests introduced themselves.

### Declaration of Pecuniary Interest

There were no declarations of pecuniary interest.

### Community Transportation

Stephanie Stewart, Manager of Community Transportation, addressed the Committee on Grey County's community transportation project. It was noted that there is currently a heavy reliance on volunteers to meet transportation needs and that youth and people living in poverty are underserved.

In 2018, Grey County worked with Lough Barnes Consulting to support a new Community Transportation Grant opportunity through the Ministry of Transportation. The

county was successful in securing 1.85 million dollars for a five-year, long distance intercommunity transportation program, as well as a local program.

Ms. Stewart spoke to the proposed route between Markdale and Owen Sound and a southbound connection to Dundalk in partnership with Southgate. There is also a proposal for a Highway 26 corridor from Owen Sound to the Town of the Blue Mountains and a connection to South Georgian Bay Transit. Local transit solutions include from Hanover to the surrounding area to help with transit to Launch Pad, and in Northwest Grey and Bruce County from Owen Sound to Wiarton.

Grey County has released a Negotiated Request for Proposal and is seeking a service provider to find a solution to meet the transportation needs of our residents.

Questions and comments from the members were then address by Ms. Stewart including the availability of parking, affordability, ticket options, accessibility, shelters, driver communication, accessibility training, baggage capacity, and the alignment with other service providers.

The Committee recommended using vertical bar automatic door openers instead of the button automatic door openers.
