Recommendation(s)

WHEREAS Plan of Subdivision File No. 42T-2010-03 received draft approval on November 15, 2011 with revisions to the plan approved on May 10, 2012;

AND WHEREAS the County is in receipt of a letter from the Applicant proposing further redline revisions to the draft plan by adjusting the distribution of semi-detached and single-detached dwelling types in Phase 2 and Phase 5 with the total number of draft approved units remaining the same;

NOW THEREFORE BE IT RESOLVED THAT Report PDR-PCD-30-14 be received;

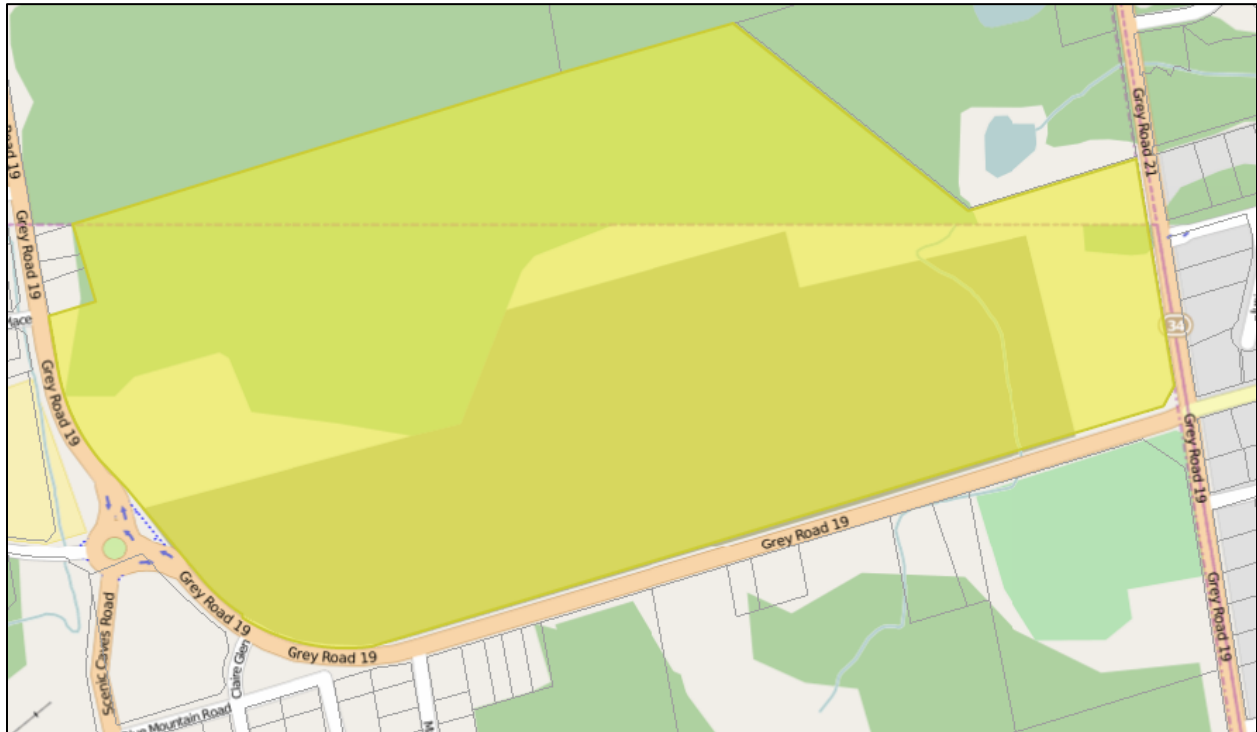
AND THAT in consideration of the redline revisions as requested to the draft plan of subdivision and the matters to be consistent with under Subsection 51(24) of the Planning Act RSO 1990 as amended, the Planning and Community Development Committee hereby approves the redline request for Plan of Subdivision File 42T-2010-03 subject to the revised conditions set out in the Notice of Decision.

Background

Plan of Subdivision File 42T-2010-03 (Georgian Gate/Windfall) was originally draft approved on November 15, 2011 and was later revised on May 10, 2012. The current draft approved plan consists of a total of 609 residential units (Lots 1 to 480 comprises

of 351 detached dwellings and 258 semi-detached dwellings) as well as the creation of a number of blocks for various purposes (e.g. open space/recreation blocks, stormwater management blocks, etc.). The draft approved subdivision is located on lands legally described as Part of Lot 16, Concession 1, Town of The Blue Mountains (see Map 1 below). The subject lands are located on the north side of Grey Road 19 between the roundabout on Grey Road 19 and the intersection of Grey Road 19 and Grey Road 21.

The owner of the subject lands has submitted a request for a redline revision to the draft approved subdivision. The proposed revisions are seeking to adjust the distribution of semi-detached and single-detached dwelling types in Phase 2 and Phase 5 through a redline revision. The net effect is to increase the number of semi-detached units in Phase 2 from 56 to 100 and by reducing the number of single-detached units from 84 to 67. The net difference in Phase 2 is an increase in the number of units from 150 to 167, however the total number of units for the entire development remains at 609 as the difference in the unit numbers is proposed to be made up in Phase 5 with an increase in the number of single detached units from 56 to 73 and a decrease in the number of semi-detached units from 50 to 16.

The proposed redline revisions were circulated to various agencies as well as members of the public that requested notice of the application as part of the previous draft approval process. Below is a link to the proposed revised plan:

Agency Comments Received

Nottawasaga Valley Conservation Authority (NVCA) – NVCA staff in correspondence dated August 15, 2014 indicates that they have no objections to the proposed redline revisions.

Ministry of Transportation Ontario (MTO) – The MTO in correspondence dated July 25, 2014 indicates that their comments dated April 4, 2011 continue to apply with respect to the redline revision. Conditions addressing transportation related matters were included in the original conditions of draft approval which are still in effect.

Town of Collingwood – In correspondence dated July 24, 2014, Town of Collingwood staff indicates they have no concerns with the proposed redline revisions.

Town of The Blue Mountains – In correspondence dated August 19, 2014, Town of The Blue Mountains staff indicate that they have reviewed the Master Development Agreement and the full plan in the context of the proposed revisions and have no concerns with the proposed redline revisions.

Public Comments Received

There were no comments received from members of the public with respect to the proposed redline revisions.

Analysis of Planning Issues:

Planning authorities must have regard to matters of Provincial interest, the criteria of the *Planning Act* and be consistent with the Provincial Policy Statement (PPS). Within Grey County they must also make decisions that conform to the County of Grey Official Plan.

Provincial Legislation – The Planning Act

Section 1.1 of the *Planning Act* outlines the purposes of the Act. The purposes of the Act promote sustainable economic development in a healthy natural environment within a land use planning system, led by provincial policy and matters of provincial interest. Section 2 of the *Planning Act* outlines matters of Provincial Interest, which decision makers must be consistent with when carrying out their responsibilities under the Act.

The proposed redline revisions have regard for matters of Provincial Interest under *the Planning Act*.

Provincial Policy Statement (PPS)

A key goal of the PPS is directing new growth to serviced settlement areas, and promoting the vitality of such settlement areas through re-development and intensification. The subdivision development is located within a settlement area designation. The proposed development would also be serviced with municipal water and municipal sewage services.

It can be concluded that the proposed revisions to the draft plan of subdivision, with the recommended conditions of draft approval, is consistent with the PPS.

County of Grey Official Plan

The County Official Plan designates the subject lands as 'Recreational Resort Area' which is considered to be a designated settlement area. The proposed revisions to the draft plan of subdivision conform to the County Official Plan.

Financial / Staffing / Legal / Information Technology

Considerations

At this point there are no financial, staffing, legal or IT considerations beyond those normally encountered in processing a redline revision. The County has collected an application and associated fee for the proposed redline revisions.

Link to Strategic Goals / Priorities

Action 2.10, under Goal 2 of the County's Strategic Plan requires the continued management of growth and the application of sound land use planning principles. Permitting residential growth in a settlement area, which efficiently uses municipal infrastructure, and provides for a range of housing opportunities, could be considered sound land use planning.

NOTICE OF DECISION

On Application for Approval of Draft Plan of Subdivision under Subsection 51(45) of the Planning Act

Draft Plan Approval was given by the County of Grey on November 15, 2011 and revised on May 10, 2012. A request has been made to further revise the draft plan. **Revised** Draft Plan Approval is hereby given by the County of Grey for the application regarding the above noted lands. A copy of the Decision is attached.

WHEN AND HOW TO FILE A NOTICE OF APPEAL

Notice to appeal the decision to the Ontario Municipal Board must be filed with the County of Grey no later than 20 days from the date of this notice, as shown above.

The notice of appeal should be sent to the attention of the Director of Planning and Development of the County, at the address shown below and it must,

- (1) set out the reasons for the appeal, and
- (2) be accompanied by the fee prescribed under the Ontario Municipal Board Act.

WHO CAN FILE A NOTICE OF APPEAL

Only individuals, corporations or public bodies may appeal decisions in respect of applications for approval of draft plans of subdivision to the Ontario Municipal Board. A Notice of Appeal may not be filed by an unincorporated association or group. However, a Notice of Appeal may be filed in the name of an individual who is a member of the association or group.

RIGHT OF APPLICANT OR PUBLIC BODY TO APPEAL CONDITIONS

The applicant or any public body may, at any time before the final plan of subdivision is approved, appeal any of the conditions imposed by the County of Grey to the Ontario Municipal Board by filing with the Director of Planning and Development of the County, or her delegate, a Notice of Appeal.

HOW TO RECEIVE NOTICE OF CHANGED CONDITIONS

The conditions of an approval of draft plan of subdivision may be changed at any time before the final approval is given.

You will be entitled to receive notice of any changes to the conditions of the approval of draft plan of subdivision if you have either,

- (1) made a written request to be notified of the decision to give or refuse to give approval of draft plan of subdivision, or
- (2) make a written request to be notified of changes to the conditions of approval of the draft plan of subdivision.

Plan of Subdivision File No. 42T-2010-03 was granted draft approval on November 15, 2011 and later revised on May 10, 2012. The draft plan is hereby **Revised**. The County's conditions of approval for this draft Plan of Subdivision are amended as follows:

No. Conditions

1. Condition 1 of the revised draft plan conditions approved on May 10, 2012 is hereby deleted and replaced with the following:

“That this approval applies to the phased Draft Plan prepared by Bousfields Inc. dated May 13, 2014 providing for the creation of a total of 609 residential units (Lots 1 to 480 which comprises of 351 detached dwellings and 258 semi-detached dwellings), a Community Forest Block (Block A), Neighbourhood Park Blocks (Blocks B to E), Private Recreation Park Block (Block F), Environmental Protection/Open Space Block (Block G), Sanitary Sewer Block (Block H), Environmental Buffer Blocks (Blocks I, J, Y, Z), Landscape Buffer Blocks (Blocks M to R), Stormwater Management Protection Block (Block S), Walkway Blocks (Blocks L, T, U), Entry Feature Block (Block V), Road Widening Block (Block W), Block to link the future Common Elements Condominium (Block X), Emergency Access Block (Block K) and Public Road Allowances within Part of Lot 16, Concession 1, Town of the Blue Mountains, County of Grey.”

2. That all other conditions of draft approval as granted on November 15, 2011 and revised on May 10, 2012 remain in effect.
