### Background

Section 284 of the Municipal Act, March 2011, requires the Treasurer of every municipality on or before March 31, to submit to the Council an itemized statement on remuneration and expenses paid to each member of Council, in respect of his or her services as a member of council in the preceding year.

The attached statement reflects the remuneration paid by the County of Grey and also includes the amounts paid to County Councillors by the Health Unit for the year 2013.

The statement does not include any expenses paid by the Association of Municipalities of Ontario (AMO) or the Ontario Good Roads Association (OGRA) to Council members who have been appointed to these associations. Nor does the statement include any remuneration or expenses paid to the County's representative of Commissioner on the Niagara Escarpment Commission.

The annual statement has been expanded to include a chart outlining council meeting attendance and compensation as per resolution CC99-13.
